



## DENTAPERX™ AFFILIATE PROGRAM – TERMS & CONDITIONS

Welcome to the Dentaperx™ Affiliate Program (the “Program”). These Terms & Conditions (“Terms”) govern your participation as an affiliate (“Affiliate,” “You”). By applying to and/or participating in the Program, you agree to these Terms.

### 1. Eligibility

To participate, you must:

- Be at least 18 years old.
- Operate a legitimate business, practice, platform, or social media presence.
- Submit accurate information during application.
- Not promote illegal, harmful, or misleading content.
- Not be employed by Dentaperx™ unless expressly approved.

Dentaperx™ reserves the right to approve or reject any application at its sole discretion.

### 2. Program Description

The Program allows Affiliates to earn commissions by referring:

- Dental clinics
- Dental service organizations (DSOs)
- Individual users/patients

Affiliates promote Dentaperx™ using approved marketing assets, tracking links, or referral codes.

### 3. Prohibited Conduct

Affiliates may **not**:

- Misrepresent Dentaperx™ as dental insurance, financing, or a government program.
- Make unverified or misleading claims.
- Collect, transmit, store, or request **Protected Health Information (PHI)**.
- Use paid advertising on Dentaperx™ trademarks without permission.
- Use spam, unsolicited emails, bots, or fake accounts.
- Use their own affiliate link for discounted personal use.
- Engage in fraudulent, unethical, or deceptive referral practices.

#### 4. Commission Structure

Commissions are earned based on successful referrals that result in approved and paying Dentaperx™ clients.

Dentaperx™ currently offers tiers such as (example):

- **Basic Affiliate:** \$100 flat fee per office that onboards on a monthly payment basis.
- **Pro Affiliate:** \$200 flat fee per office that onboards on a yearly payment basis.

Dentaperx™ may update commission structures with notice.

#### 5. Payments

Payments are issued monthly, net-30, once:

- A referral has converted to a paying client.
- The client has remained active past the refund period.
- Minimum payout threshold of \$50 is reached.

Payments may be made through:

- PayPal
- Venmo
- Bank Transfer
- Stripe Payouts

Affiliates are responsible for providing accurate payment details and tax information (W-9 for U.S. affiliates).

#### 6. Marketing Requirements

You agree to:

- Use only Dentaperx™ - approved branding and materials.
- Clearly disclose affiliate relationships (FTC compliance).
- Follow healthcare advertising standards.

Dentaperx™ may request edits or removal of noncompliant promotional content.

#### 7. Intellectual Property

Dentaperx™ owns all rights to its trademarks, logos, branding, content, and product names. Affiliates receive a **limited, non-exclusive, revocable license** to use approved materials solely for Program participation.

Unauthorized reproduction, modification, or resale is prohibited.

## **8. Confidentiality**

Any non-public business, pricing, or product information provided by Dentaperx™ must remain confidential.

## **9. Termination**

Dentaperx™ may terminate your participation:

- At any time, with or without cause.
- Immediately for violations of these Terms.
- If fraudulent or unethical behavior is suspected.

Upon termination:

- You must stop using affiliate materials.
- You will receive unpaid but earned commissions unless terminated for misconduct.

## **10. Limitation of Liability**

Dentaperx™ is not liable for:

- Loss of profits
- Lost data
- Delays or interruptions
- Indirect, incidental, or consequential damages

Participation is “as-is” with no guarantee of earnings.

## **11. Taxes**

Affiliates are independent contractors and responsible for all applicable taxes.

## **12. Modifications**

Dentaperx™ may update or modify these Terms at any time. Continued participation constitutes acceptance.

## **13. Governing Law**

These Terms are governed by the laws of the State of Texas (or your preferred jurisdiction), without regard to conflict-of-law principles.
